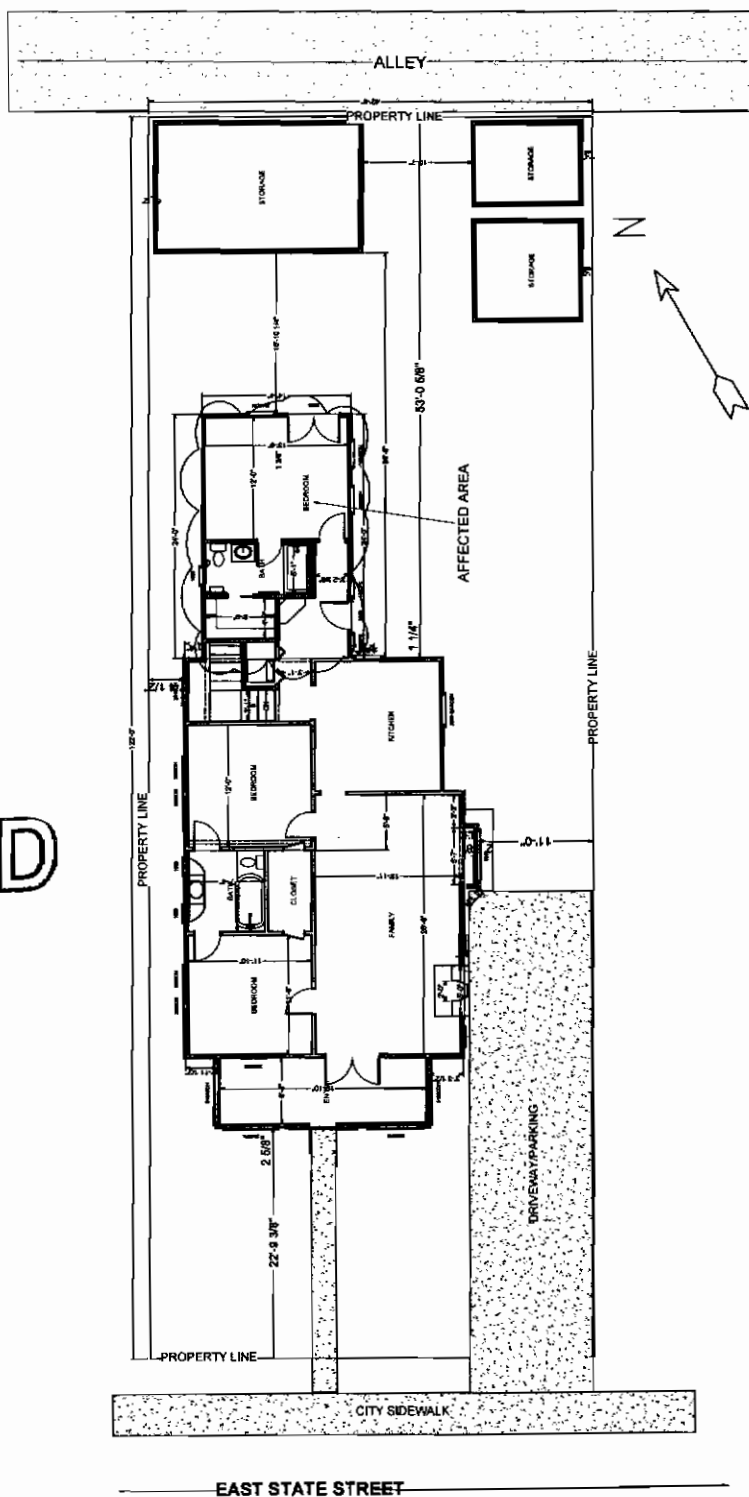

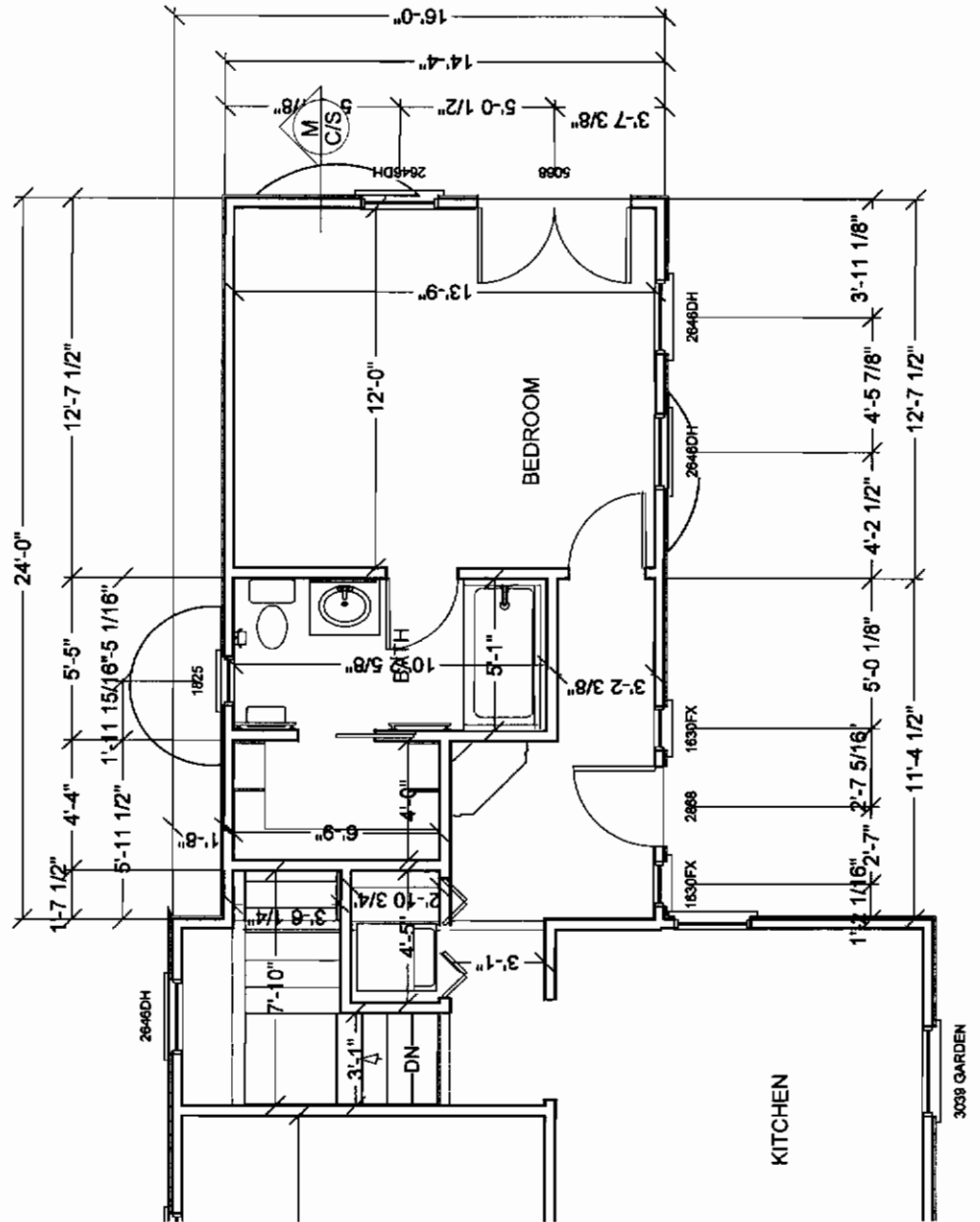

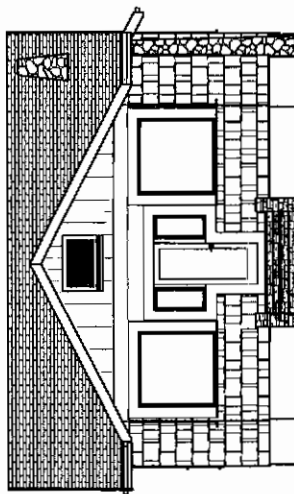

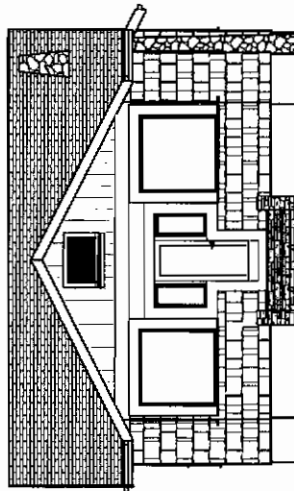
EXTERIOR ELEVATIONS -1

EXISTING ELEVATION FROM STREET



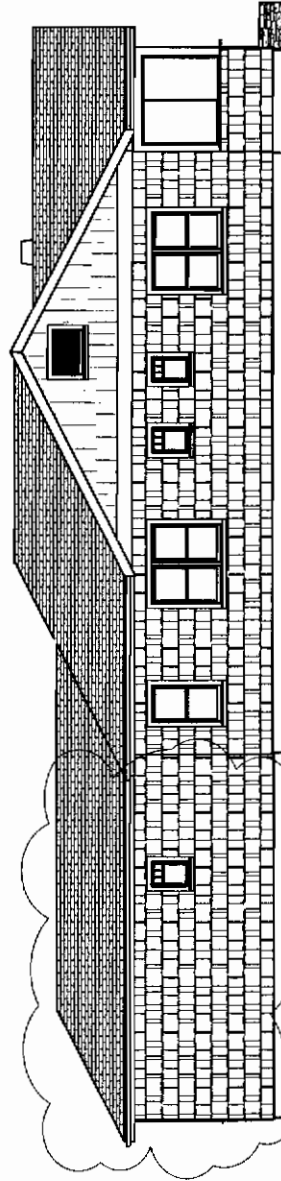

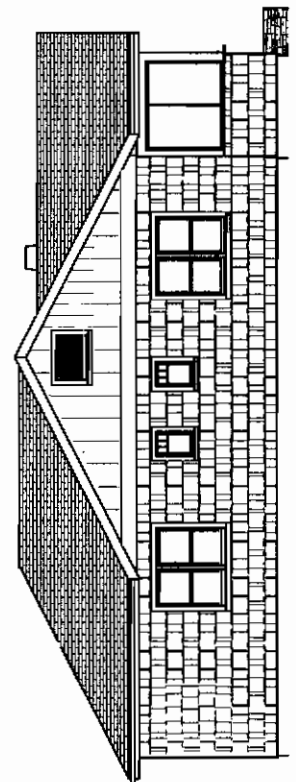

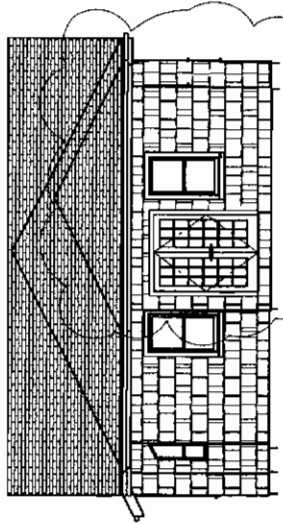

EXISTING REAR ELEVATION



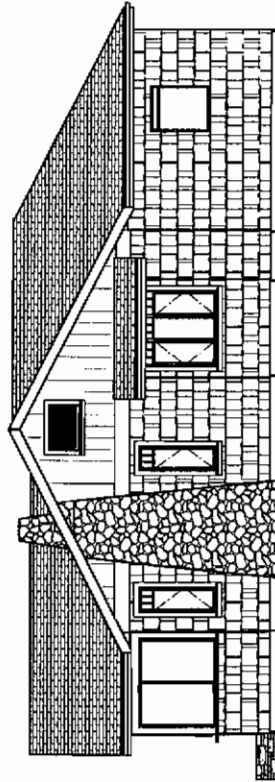

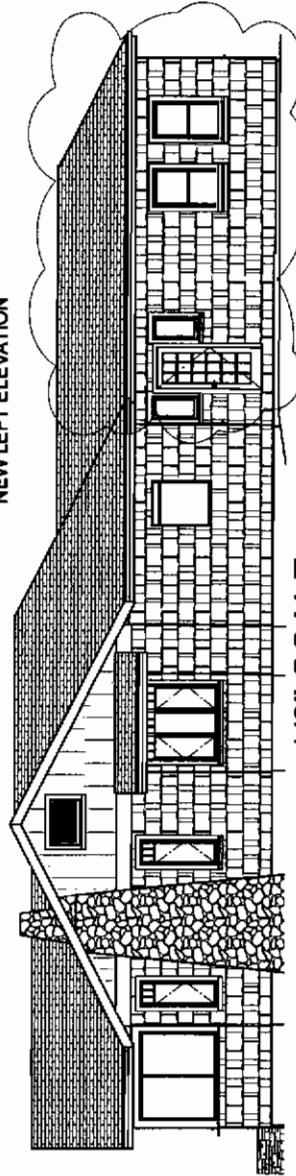

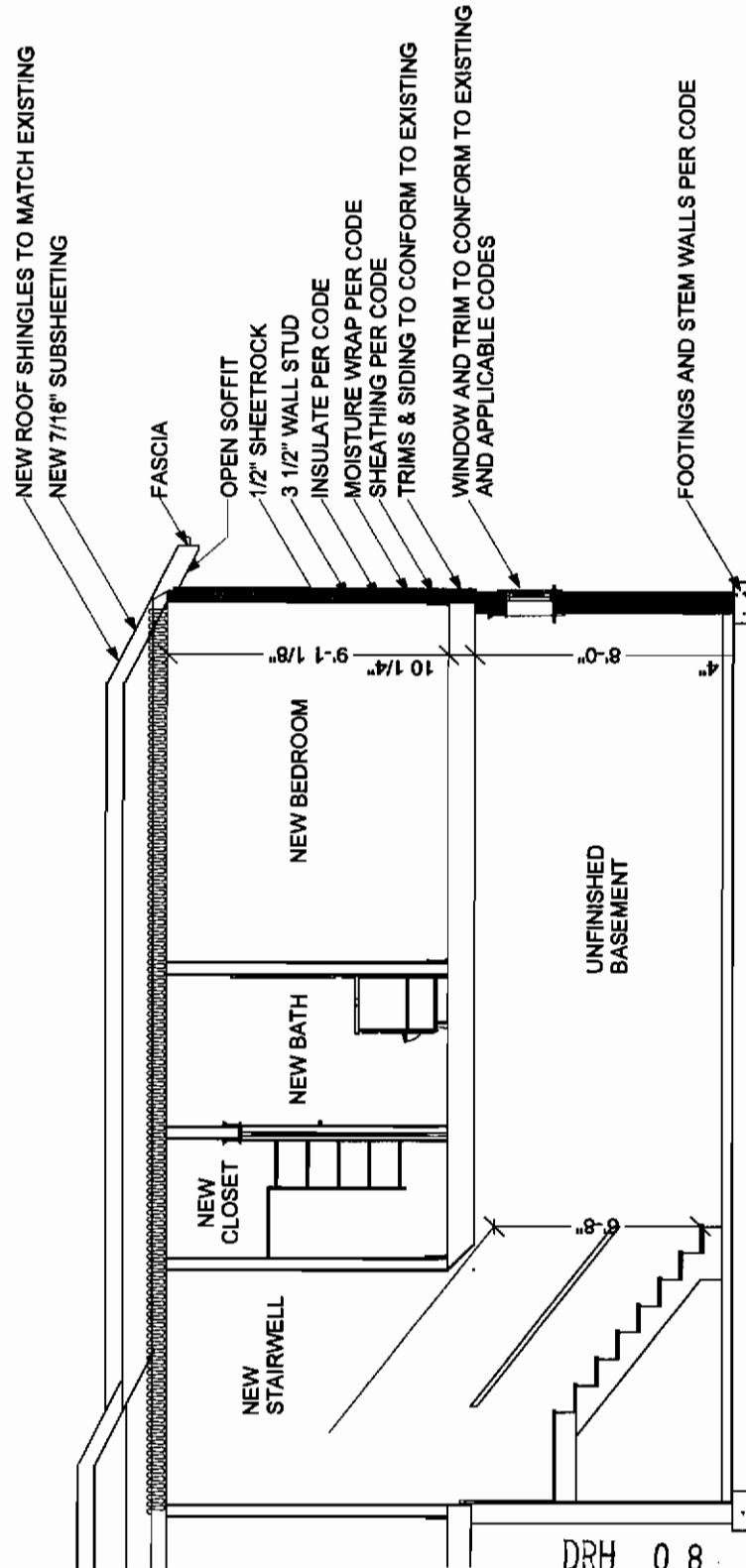
