Specific Plan Kinsten ringa Valley Subdivision

I am here to talk about the Syringa Valley Subdivision, specifically the traffic concerns we, the signees of this petition, and others have for this area.

Originally the Cole south traffic study was done at night.

It is a 2 lane road.

This study does not reflect the true grid lock that occurs at 7:30 in the morning.

With increased construction, united water putting in utilities, and more home owners, the traffic concerns will only prove more severe, and could be a safety hazard, an example being for ambulances or fire trucks with their station being on Cole.

The ACHD board has made a recommendation for a temporary road for construction connecting to Orchard.

We would like the City to see the necessity for making the Lake Hazel extension east of Cole road to Gowen and south to Orchard a permanent road before the 170 homes are built.

The Syringa Valley Specific Area Plan states it will do this only after 170 are built.

We want to assure that the road will be in place even if their is a problem with finishing the construction of the homes due to the economy, which put a delay on this subdivision originally.

A permanent road would alleviate the traffic concerns which is what most of the current subdivision homeowners are worried about.

Completion of this road prior to the development will be a win win for everyone, the people, the developer and the city.

Greetings,

At this time a construction plan is under review for a new major development in the south part of Boise, and may be approved and started soon. The planned neighborhood, called Syringa Valley, is to be constructed on the range land between the airport and the Peregrine Fund bird refuge.

The plan for Syringa Valley was approved some years ago when population and traffic density in the Southwest Ada County area were significantly less than they are now. The construction and population growth in this region during the intervening years raises concerns of traffic congestion and safety on the existing roads, as well as population density issues which conflict with the city's Comprehensive Plan. This is a great area to live in, and we want to help make sure it stays great as Boise grows.

By signing this petition, we request the completion of the Orchard to Lake Hazel Road extension be a condition of acceptance of the Syringa Valley specific plan. We also ask you to support a review of the density of this plan to address safety and environmental impact concerns in the Southwest Ada County area.

Opinions on the Syringa Valley construction are not unanimous. Some welcome the construction, while others do not. We who live in the neighboring areas all agree, however, that the plan must be updated to avoid such complications as overpopulation and aggravated traffic congestion.
